Courses chosen can include, but do not have to include, any CME course not already completed.

Thesis – Credits: 6

CIG 699: Curriculum and Instruction Thesis

(Students may not enroll in thesis credits until they have passed their thesis proposal defense and secured IRB approval or exemption for their thesis study. Students must enroll in thesis credits over a minimum of two semesters. Students must be enrolled in at least 3 thesis credits the semester they graduate.)
